# DIRECTIONS

## CONCORD OFFICE

### From the **NORTH**

- Travel I-93 South to Exit 14
- Take a right at the end of the ramp
- At the 2nd light take a left onto N. Main Street
- At next light take a right onto Pleasant Street
- At the 5th light (1.5 miles) take a right onto Langley Parkway
- Take next left into the Concord Orthopaedics parking lot. The main entrance is on the left.

### From the **SOUTH/WEST**

- Travel I-93 North to the Exit for I-89 North
- Take exit 2 (Clinton Street)
- At the end of the ramp take a right onto Clinton Street
- Proceed .7 mile to the first set of lights
- Take a left onto Langley Parkway
- Follow Langley Parkway to traffic light at the Pleasant Street intersection
- Proceed straight through the light, take your first left into Concord Orthopaedics parking lot. The main entrance is on the left.

## NEW LONDON OFFICE

### From the **NORTH**

- Travel I-89 South and take Exit 12
- Take a left off the exit and follow Newport Road approximately 2 miles to the roundabout
- Stay to the right turning onto County Road
- Follow the signs to the hospital
- Take a left into the hospital parking lot
- Enter the Main Entrance to the hospital

- Follow Route 28, passing through a series of traffic lights
- Turn left onto Tsienneto Road, to Overlook Medical Park Building, on the left, 2nd floor
- For those needing extra assistance getting in and out of a car, please use the circular drive in front of the main entrance to drop off or pick up.

### From the **SOUTH**

- Travel I-93 North and take Exit 4, Route 102 East towards Derry
- At the end of the ramp, bear right onto Route 102/Nashua Road
- Turn left onto Crystal Avenue
- Turn right onto Tsienneto Road, to Overlook Medical Park Building on the left, 2nd floor
- For those needing extra assistance getting in and out of a car, please use the circular drive in front of the main entrance to drop off or pick up.

## **WINDHAM OFFICE**

### From the **NORTH**

- Travel I-93 South to Exit 3
- Take a left at the end of the ramp onto Route 111
- Travel .7 miles through 2 sets of lights
- Our office is located in Castle Commons on the right hand side

### From the **SOUTH**

- Travel I-93 North to Exit 3
- Turn right at the set of lights at the end of the ramp onto Route 111
- Proceed through another set of lights
